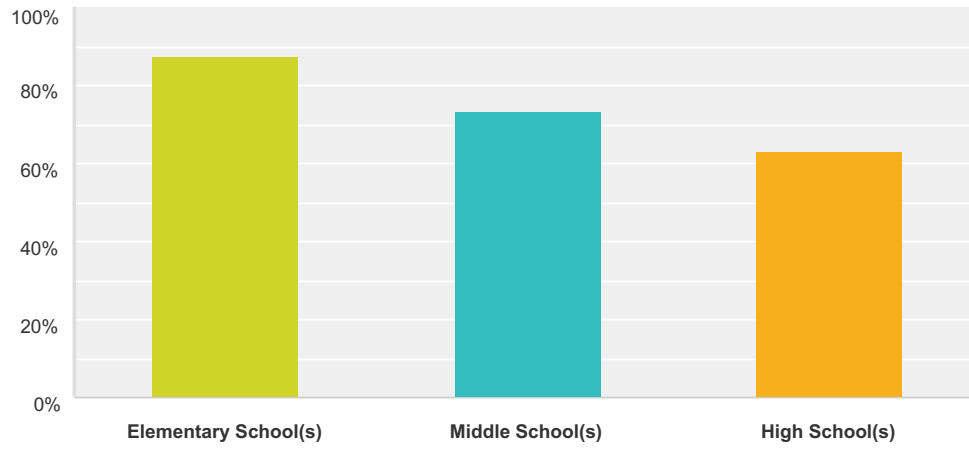


Q1 Please describe the schools in your school district. (Check all that apply)

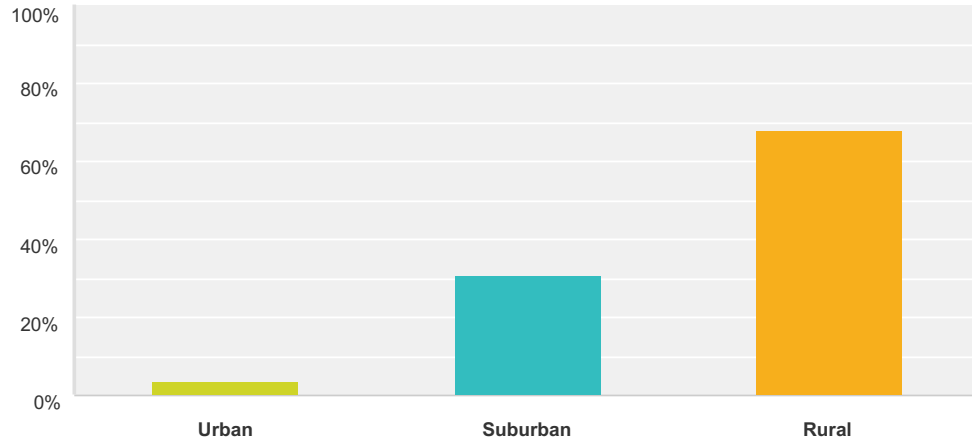

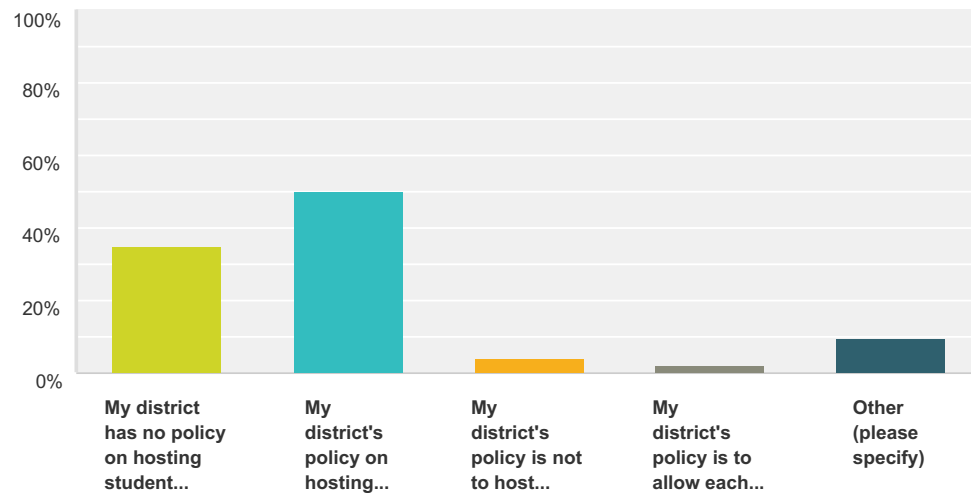
